TERMS AND CONDITIONS OF TOUR
SEPARATE FORMS TO BE READ AND SIGNED BY THE BOOKING
APPLICANT AND ALL DESIGNATED DRIVERS

The Booking Applicant/Designated Driver on behalf of himself or herself and on behalf of his or her passengers:

1. acknowledges that the tour may involve risks additional to those which may occur in the ordinary course of four-wheel driving or motorcar touring on sealed roads,
2. freely accepts the risks of four-wheel driving, motorcar touring and of the tour itself and releases Traction 4 Drive and Dive Club Inc., Drive 4 Life, 4 Wheel Drive for Wheelchairs, The Northcott Society, Overlander 4X4 Magazine, ARB Corporation Limited, Cooper Tyres, Tour Sponsors, their principals, employees, drivers and agents (collectively called “the organisation”) from legal responsibility for any injury, illness, death, damage to property responsibility (including consequential loss) costs or expenses sustained by the Booking Applicant/Designated Driver and/or the Booking Applicant’s/Designated Driver’s passengers in the course of the tour and this release shall apply even where the organisation may be in breach of contract or negligent,
3. will indemnify the organisation against any claims or demands of any nature which may be brought against it by the Booking Applicant/Designated Driver or the Booking Applicant’s/Designated Driver’s passengers or by any person on their behalf arising out of the tour,
4. accepts full responsibility for the safety of the Booking Applicant/Designated Driver and the Booking Applicant’s/Designated Driver’s passengers and for the safety and preservation of all property brought on the tour by the Booking Applicant/Designated Driver and the Booking Applicant’s/Designated Driver’s passengers,
5. will not make any claim against the organisation arising out of participating in the tour,
6. will obtain competent advice on all appropriate insurances (such as comprehensive motor vehicle insurance, personal and accident insurance, ambulance insurance and property insurance) which should be effected on a tour of this nature and accepts the risks of failing to effect appropriate insurance,
7. warrants that the Booking Applicant/Designated Driver and any of the Booking Applicant’s /Designated Driver’s passengers who may intend to drive at all on the tour, holds a current driver’s licence,
8. warrants that the Booking Applicant/Designated Driver and the Booking Applicant’s/Designated Driver’s passengers do not suffer from any pre-existing illnesses or ailments or conditions, in so far as they are aware, or discloses such at the time of lodging the booking application,
9. authorises but places no legal obligation on the organisation to render or obtain such medical or emergency assistance as it may consider appropriate for the safety and comfort of the Booking Applicant /Designated Driver or the Booking Applicant’s/Designated Driver’s passengers,
10. agrees that these conditions shall be binding upon legal personal representatives of the Booking Applicant /Designated Driver and the Booking Applicant’s/Designated Driver’s passengers.
